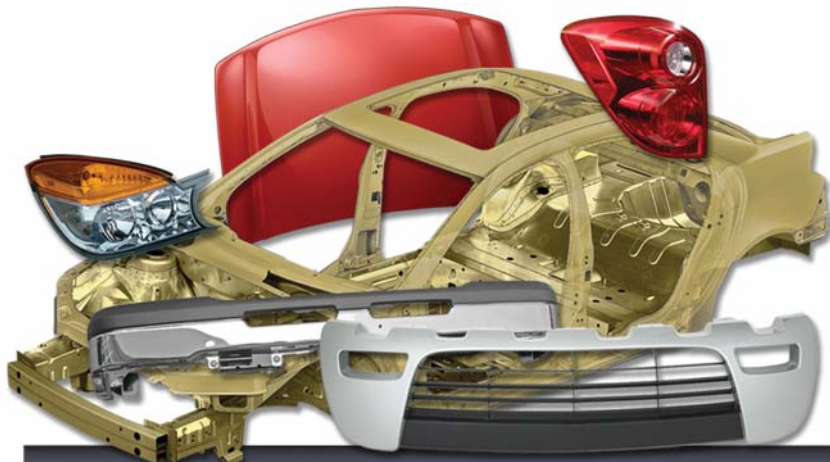

GM Parts Fast-Cash Rebate Program

Here's how to request a rebate:

1. Go to www.gmpartsfastcash.com. Log in to gain access to the website
2. Follow the rebate submission steps.
3. Submit a claim for each unique invoice for qualifying GM Collision Parts.
4. Mail, Fax or Email the printed online claim confirmation page with copies of the dealer invoice and your repair order and/or a copy of the estimate* to:

January 1 to June 30, 2012 Genuine GM Parts Fast-Cash Rebate Program Rules

- These program rules are effective for the Fast-Cash program that runs January 1 to June 30, 2012.
- Excludes warranty work.
- Any Genuine GM Parts Hood, Fascia, Headlamp Assembly, Tail Lamp Assembly, Bumper, Energy Absorber, Bumper Reinforcement Bar or Radiator Core Support specified on a repair shop repair order (or estimate) and installed in place of an aftermarket version is eligible for a \$15 Fast-Cash rebate.
- Only one rebate allowed for an individual valid part number on a rebate claim.
- To be eligible for Fast-Cash rebates, Genuine GM Parts must be purchased from an authorized Genuine GM Parts Dealer.
- To submit a rebate claim, please go to www.gmpartsfastcash.com and follow the online instructions. You will be required to register/log on to the website to submit a rebate claim.
- The online Rebate Claim Confirmation must be printed and then mailed, faxed or emailed as a PDF to Program HQ along with copies of the associated GM Dealer invoice and your repair order and/or copy of the estimate. Mail to: Genuine GM Parts Fast-Cash, 2604 NE Industrial Dr. #230, N. Kansas City, MO 64117. Or, Fax to: 816-268-5280. Or, Email to claims@gmpartsfastcash.com.
- Repair order and dealer invoice must be dated within six weeks of each other.
- Rebate requests must be postmarked by July 31, 2012. All requests are subject to validation and approval of GM. Incomplete rebate requests may delay or invalidate rebates.
- Visa Award Card(s) will be mailed to the individual at the Collision Repair Shop named on the rebate form.
- Allow 6-8 weeks for delivery of Visa Award Card(s).

- GM reserves the right to change or cancel this program.

*GM dealer body shops only need to submit their printed confirmation pages and copy of estimates.
